RECOMMENDATION:

Over the last several meetings, the Mayor and City Council have received updates regarding the 4th of July event. On June 4, 2024, the Mayor and City Council provided direction to the City Manager's Office to develop agreements with various vendors based on the approved schedule provided by the Ad-Hoc.

Additionally, the Mayor and City Council provided direction to the City Manager's Office to develop an agreement with Ricky Ricardo Productions for musical entertainment including a jariepo for the event.

Staff has yet to receive a formal proposal from Ricky Ricardo promotions for the event by the time of the posting of the agenda, but staff has been informed that the total cost of the musicians and jaripeo total \$12,500.

Staff is recommending that the Mayor and City Council adopt a resolution authorizing the execution of an agreement with Ricky Ricardo Promotions for a not to exceed amount of \$12,500 subject to legal concurrence from the City Attorney's Office.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LIVINGSTON AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE AN AGREEMENT WITH RICKY RICARDO PRODUCTIONS FOR ENTERTAINMENT FOR THE CITY OF LIVINGSTON 4TH OF JULY EVENT

WHEREAS, the City Council desires to have 4th of July celebration in the City of Livingston;

WHEREAS, the City Council has appointed two Council members to serve on an Ad-Hoc Committee to develop recommendations regarding the 4th of July event;

WHEREAS, the Ad-Hoc Committee has recommended a schedule of events for the 4th of July celebration which was approved by the Mayor and City Council on June 4, 2024.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Livingston as follows:

Section 1. The City Council authorizes the Interim City Manager to execute an agreement with Ricky Ricardo Productions for musical entertainment including live music and a jaripeo subject to approval and concurrence by the City Attorney with a not to exceed amount of \$12,500.

Section 2. That the Finance Department is authorized to take any and all actions necessary to carry out the above mentioned actions.
